6. Please pick up ceremonial salmon at the FWC office, 315 "B" Street, Lapwai, ID.

7. Ceremonial spring chinook salmon was caught in May 2018. Proper thawing of frozen fish is important to maintaining fish quality. We recommend thawing frozen fish in the refrigerator for up to 2 days before cooking (rotating fish as needed), and never thaw fish in hot water or at room temperature. Care is taken to provide you with quality ceremonial salmon. If you have concerns about the quality of the fish you receive, immediately contact Nancy McAllaster at (208) 843-9376 ext. 4649, and fish will be **exchanged** if time allows. In some cases, the seal on the plastic bag may break resulting in the fish drying (or suffering "freezer burn") on the edges; if that has occurred, the dried edges may be cut and removed before preparing the fish. However, if the fish smells bad, DO NOT cook the fish, return it to the FWC immediately.

- Salmon received from the Fish and Wildlife Commission and that it will be used for intended purpose.
 - Will NOT SELL the ceremonial salmon received, and doing so may result in a citation per Tribal Code § 3-1-48 (a) (3) & (7) and will prevent applicant from receiving tribal fish from distributions for three years from today's date.
 - Agrees to **immediately contact the FWC office to pickup ceremonial salmon** received in the event it is not in good condition and **cannot be used**.
